Motion: Benjamin made a motion to adjourn at 8:25pm.



Specifically:



I think that it would be prudent for all of the parcels within the neighborhood to be serviced by the same Fire Department. There must be some synergies and less confusion for the departments. It wouldn't make much sense for say Edwardsburg to drive through the front half of a neighborhood which happens to be in District One to access District Two in the back half of the neighborhood.

I feel that the best way to facilitate this would be through the subdivision or Site Condominium approval process as I'm sure that these anomalies may present themselves in the future as other parcels are developed along the School/Fire District lines.
