Community Reports

Zoning Administrator reported there have been 2 site planes, 1 variance request, and 3 lot line change requests. The master plan map has been updated. On January 30, 2012 the court ruled that they stay for 5 Star was denied, the stay for tickets was denied, and they must post a \$5,000.00 bond for land restoration.

Planning Commission reports that there will be a public hearing for the draft master plan on March 12, 2012 at 6:30 PM.

County Commissioner reported that the county administrator has resigned and they are looking for a replacement. The two building projects are going well, one is a new building at Lawless Park and the other is an addition to the animal control.

Building Inspector reported that last year we had four new homes averaging \$500,000.00, seven accessory buildings averaging \$26,000.00, and six pools averaging \$20,000.00. For a total tax gain of about \$1,200,000.00.

Niles Township Fire Department reported that they are working with Cass County to get 911 calls correctly forwarded to the correct area. They have also finished the ISO evaluation, but they do not have the results at this time.

Edwardsburg Ambulance reported that last quarter they had ten runs in Milton Township and only seven of those were transports.

Cass Country Sherriff reported that next meeting the MDOT will hold a meeting for US-12 construction. This meeting will be March 7, 2012 at the Milton Township Hall from 3 – 6 PM. There has been an increase in daytime B&Es in the area.

Community Advisory Committee presented her report on the committee's findings, and presented a Noise Ordinance that the committee recommended.

Niles Township Fire is interested in covering the entire township and they should be able to keep the same response times that Edwardsburg Fire currently provides.

It is currently illegal in the State of Michigan to contract with an out of state fire department, so Clay Township was not looked at.

There was much discussion; this is staying as old business for now.
