WHEREAS, the Michigan Planning Enabling Act, MCL 125.3801 *et seq.* (“MPEA”) authorizes the Planning Commission to prepare a Master Plan for the use, development and preservation of all lands in the Township; and

WHEREAS, the Milton Township Planning Commission has undertaken an effort to evaluate and update the Township’s Master Plan and has assembled a revised draft Master Plan update; and

WHEREAS, the Michigan Planning Enabling Act, MCL 125.3842, requires the Township Board to authorize distribution of the Master Plan to the notice group entities identified in the MPEA; and

WHEREAS, the Michigan Planning Enabling Act, MCL 125.3843, provides the Township Board with the option to assert their right to adopt the Master Plan.

NOW, THEREFORE, BE IT HEREBY RESOLVED AS FOLLOWS:

1. ***Intent to Adopt Master Plan.*** Pursuant to MCL 125.3843, the Milton Township Board hereby asserts its right and intention to adopt the updated Master Plan.

2. *Distribution of Draft Master Plan to Notice Group.* Pursuant to MCL 125.3842, the Township Board hereby approves distribution of the draft updated Master Plan to the Notice Group outlined in MPEA for review and comment.
