Annual Report to the Board of Trustees

Township Fiscal Year 2011-2012 (4/1/2011-3/31/2012)

Over the past fiscal year, the Planning Commission has worked diligently updating the Master Plan for Milton Township. Through the year we have been working on several of the Zoning Ordinances and are in process of doing a complete Zoning Ordinance Audit. The Planning Commission has completed a Medical Marihuana Ordinance, Section 20.02 and the Private Road Ordinance, Article 23. The Planning Commission, under the request of the Board of Trustee's, also developed a Road Repair Plan.

In addition, the Planning Commission has completed the following specific actions:
